This Disclaimer is between "you" and Fire Fighters Trading Limited (company number 03816625) or Fire Fighters Charity (company no. 04480058, charity no. 1093387 (England & Wales) and SC040096 (Scotland)) (we / us / our) and applies when we provide services which may benefit you.

All guests residing at our center's with dog(s) are required to read, sign and adhere to the information contained in the responsible owner's disclaimer. If these requirements are not met, The Fire Fighters Charity reserves the right to ask the guest to remove the dog(s) from site. Where this is not possible, all guests in the party may be asked to leave site. If this occurs, and payment has been made to the Charity for your accommodation, no refunds will be given.

Responsible Owner Terms of Use

Requirement	Guest Signature
I confirm that my dog has received and is current with all required injections and immunisations and confirm the dog does not have any communicable illnesses or diseases. I can produce these records if required.	
I understand and agree that I am responsible for any claims made by any third-party for loss, damage or injury caused by my dog.	
I understand and agree that dogs must be always kept on a short lead when outside of my allocated accommodation. Including when using the patio area or front garden of the accommodation.	
I understand and agree that I am responsible for picking up and disposing of any dog waste in the waste bins provided.	
I understand and agree that my Dog must be supervised by me at all times and cannot be left in my accommodation unaccompanied. The only exception is for catered guests who can leave their dogs, but only for the duration of their	

meal. Dogs should only be left if you are sure they will not cause a noise nuisance to others.	
I understand and agree that Dogs are not permitted in the any other building apart from my accommodation whilst I reside at the center. This includes all other guest properties. Dogs are permitted on the veranda outside of the bar area but must be on a short lead and be accompanied by their owner. Should you dog enter other buildings not designated as pet friendly, an additional cleaning charge may be applied.	
I understand and agree that Dogs are not permitted on the	
furniture including the beds within my allocated	
accommodation. I understand that I am responsible for all	
costs associated with any damage caused to the property	
during my time at the centre.	
I understand and agree that my Dog is not permitted to	
upset or annoy other residents this includes excessive	
noise. I understand that should this happen; I may be asked	
to find alternative arrangements for my dog for the	
remainder of my stay.	
I understand and agree that the Charity retains the right to	
exclude my dog if, at the Charity's discretion, my dog is	
considered dangerous or is likely to frighten or harm others	
I understand that I am responsible for the safety of my	
dog(s) whilst at the centre.	
Harcombe House Only - With the exception of registered	
assistance dogs, dogs must not enter the children's play	
area.
